Dear Judge Gard,

We regret very much the long delay in reporting to you about the results of a search made for record of your family but we were reluctant to close the search until all available records had been consulted.

Evidence has been obtained of families named Ireland in Belfast who were connected with the copper and tinsmith trade but due to lack of registers, particularly those of Presbyterian churches, in Belfast, we have not been able to prove a connection between these families and Robert Ireland.

There are a number of Ireland families living in Belfast and if you would like me to contact them I shall be pleased to do so.

The report and notes from records examined are enclosed together with the account.

REPORT

The family of Robert Ireland was undoubtedly Presbyterian. The publication presented to Robert by his sister Elizabeth and the tradition of Robert, the father, as a defeated rebel would point to this fact. The Hearthmoney Rolls, dated 1663-4, record three entries under Ireland. These people were the original (or sons of the original) settlers in Northern Ireland. There is no Hearthmoney Roll for Co. Do but apparently a family of the name settled also in Ballynahinch area in the seventeenth or eighteenth century. No mention was found of Irelands in records available for Co. Londonderry. Perhaps Robert sailed from the Port of Londonderry in 1831.

A search in Belfast Directories from 1819 (none was published for the period 1820 to 1830) recorded entries under James Ireland, who was a copper and tinsmith Cornmarket up to the year 1850, and also of a David Ireland, copper and tinsmith from 1833 to 1850 who lived in Cromac Street and District.

An examination was made of St. Anne's (Protestant Episcopal) and Rosemary Street (Presbyterian) church registers for the dates noted. These are the only two churches in Belfast with records of baptisms, etc., covering the eighteenth and early nineteenth centuries. No entries were found, however, in the aforementioned registers of Robert, 1765, or his children, born 1799 to 1809. Record was obtained of the family of James Ireland, copper and tinsmith, and of his brother John, both of Cornmarket. The Will Index for Connor (Antrim) Diocese up to 1858 listed a number of Irelands but, unfortunately, these Wills were destroyed in Dublin, in 1922 during the Civil War in southern Ireland as were also, at the same time, Census Returns dating from 1821. Extracts of a few of the Wills are available and copies of those relating to Irelands are enclosed.

The register of Clifton Street Graveyard (Presbyterian), dating from 1795, record in many instances family details of those buried there. A thorough examination was made up to 1900 of indexes, memorials and notes of purchases of grave plots and all entries to Ireland extracted. There is a certain amount of repetition in the entries but as some of the indexes mentioned more details than others all references have been included.

The search was continued in Will Calendars from 1858 to 1900 and extracts made of Ireland Wills.

In combining the information obtained from the records examined it was found possible to compile a pedigree of the family of James Ireland of Cornmarket, later of Hollywood, and also of other Ireland families.

Little, however, appeared relating to David Ireland of Cromac Street and area. The burial register of Clifton Street (or Carlisle Circus) records the death of William, born 1816, a tinsmith, son of James and Eliza Ireland of Trafalgar Street, formerly of Co. Armagh. Dry Dock is an address also in the area of Trafalgar Street and Alexander, who was born 1772 in Keady, Co. Armagh, died 1847, may have been a connection (? brother) of John Ireland. Little York Street is also in the same area as Trafalgar Street.

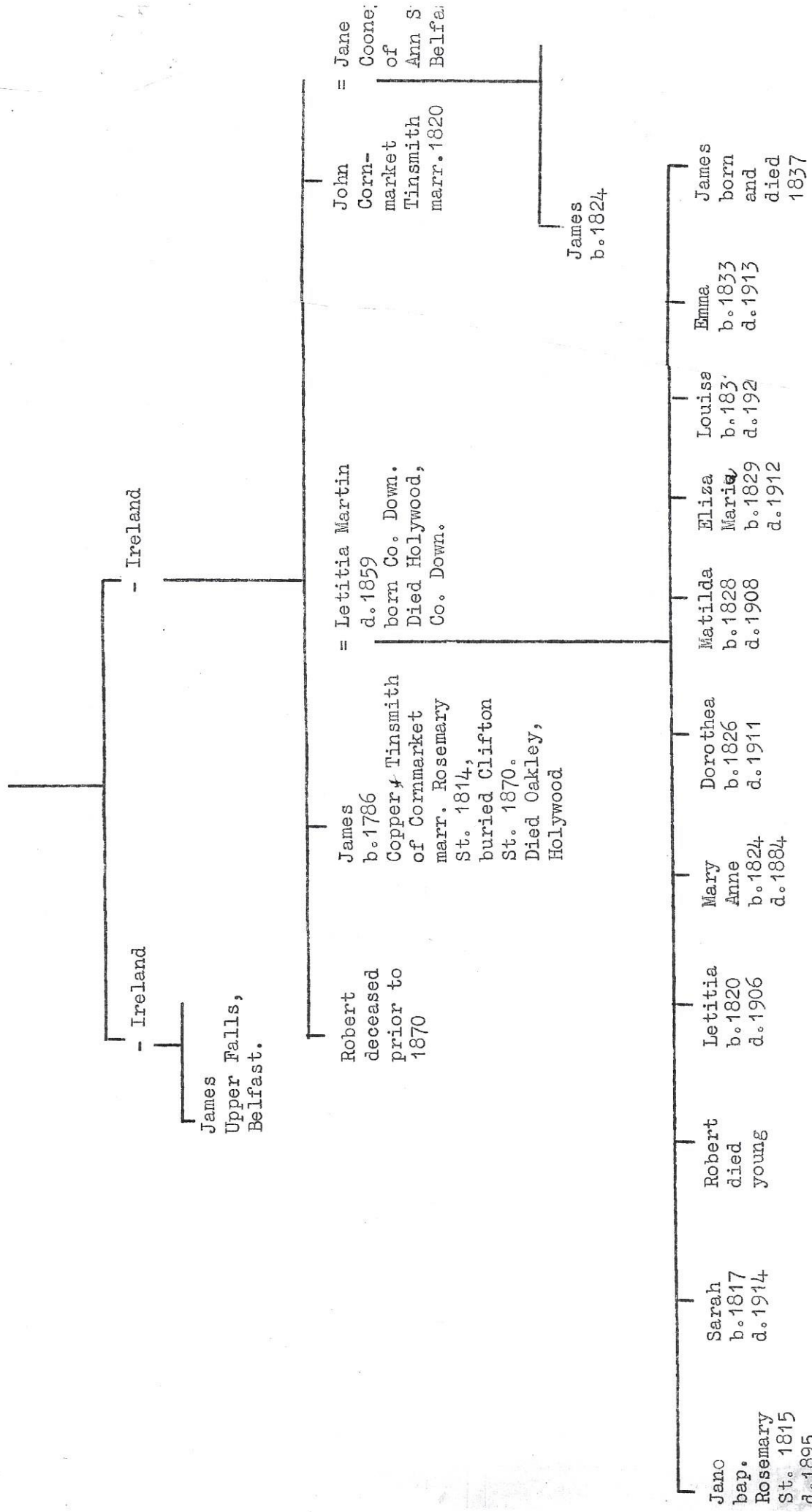
